
DIVIDENDS IN CENTS PER SHARE

PORTFOLIO COMMENTARY

Market Review

The S&P/ASX 300 Accumulation Index (benchmark) rose 1.0% in February. Reporting season dominated the month with core thematics including rising costs as well as a resilient consumer. Traditional value sectors like Energy (-5.9%) and Materials (-4.8%) struggled in the face of questions around China's economic growth whilst the small but frothy IT sector surged (+19.7%), echoing the tech boom offshore. Big resource names like Fortescue (-9.6%), Woodside (-6.3%) and Rio (-6.9%) dragged on the benchmark. Meanwhile the Consumer Discretionary, Real Estate and Financial sectors were all outperformers.

Portfolio

The PIC portfolio returned 2.6%, outperforming the benchmark by 1.7% in February. Quality businesses did well in this environment with key PIC holdings such as Goodman Group, A2 Milk and Light & Wonder all showing strength and contributing to outperformance of the portfolio versus the growthier pull of the market.

The overweight position in GWA Group (+20.7%) contributed to performance over the month. The 1H24 result saw volume growth in the core Australian business for the first time in many years thanks to investment in re-engaging with the plumber. The company also benefitted from deflationary tailwinds from manufacturers in China. This, combined with the ability to further push prices saw gross margins expand almost 300bps. GWA Group's diverse product portfolio, encompassing bathroom and kitchen fixtures, along with its robust relationship with distributors, positions the company for sustained growth. The prevailing trend of mergers and acquisitions in the building suppliers sector is also a further potential source of upside.

Light & Wonder (+26.9%) substantially contributed to the portfolio's performance as it re-rated on the back of an impressive fourth quarter result. Light & Wonder delivered a result ahead of analyst expectations, driven primarily by outperformance in the core land-based gaming division. The strong performance of one of its new release games, Dragon Train, in the home Australian market is of particular note. Dragon Train is showing strong early signs of success with leading game performance translating to market share gains. The game is expected to be imminently released into the larger US market, providing a solid foundation for anticipated earnings growth in 2024.

Over the past few years, Light & Wonder has undergone a significant transformation, resulting in a repositioned company with a robust balance sheet, an exceptional management team, creative talent, and a clear strategic vision. Pleasingly, recent operational results suggest that the foundational changes made in the business are translating to better products for customers and ultimately better earnings and overall outcomes for shareholders. Despite the recent re-rate, we maintain that the company trades at an attractive valuation relative to its attainable growth prospects.

A2 Milk significantly contributed to the portfolio's returns in February, rising +19.9%. This can be attributed to a strong 1H24 result where sales and operating margin held despite the backdrop of a shrinking China IMF market. A2 upgraded full year FY24 forecast fuelled by robust sales in mother-baby stores and cross-border e-commerce. Moreover, Kantar market share data underscores A2's increasing market presence in both offline and online channels. A2 Milk has successfully evolved from a rapid-growth startup to a well-established, professionally managed entity with a brand that resonates with Chinese consumers. The company exhibits adept inventory and pricing management, and our confidence in the returns generated from its marketing investments is growing. With a robust balance sheet boasting over \$790 million in cash, we view A2 as being well-positioned for strategic manoeuvring in the face of the challenging macroeconomic landscape.

Outlook

We believe a great deal of uncertainty lies ahead. Inflation, which seemed beaten in the US, is showing signs of life again and could be a leading indicator of further inflation in Australia. This in turn is leading to questions about the timing and speed of Fed and RBA rate cuts. Australia is also more exposed to a very uncertain growth profile in China where policymakers are battling dour consumer sentiment and an ongoing property downturn. Geopolitical and policy risks abound. We continue to seek high quality businesses at reasonable valuations to navigate these choppy waters.
